Macroeconomic

Following were the major activities during the month of September, 2013 regarding this Section:

- A consultative workshop on the preparation of Pakistan Vision 2025 and 11th Five year Plan 2013-18 was conducted by Ministry of Planning, Development & Reform in collaboration with McKinsey and Company Dubai on 5th September, 2013. Senior officers of the Federal Government Ministries and attached Departments attended the workshop. McKinsey & Co. has vast experience in economic development strategy formulation. The Workshop focused on the country transformation with special emphasis on transformation of State Own Enterprises (SOEs), energy policy formulation, internal resource mobilization and value addition in agriculture.
- A delegation of Pakistan Business Council, led by Mr. Sikander Mustafa Khan, Chairman Pakistan Business Council (PBC) and prominent business leaders in Pakistan visited Ministry of Planning, Development & Reform for consultative meeting on Pakistan Vision 2025 on 24th September, 2013. Prof. Ahsan Iqbal, Federal Minister for Planning, Devel-

opment & Reform chaired the meeting which also included Mr. Hassan Nawaz Tarrar, Secretary for Planning, Development & Reform and numerous other senior officers from the Ministry. In his opening remarks, Prof. Ahsan Iqbal lauded the role of private sector in improving and enhancing the economic productivity of Pakistan. He said "Building a robust, vibrant and competitive private sector is pivotal in government's future economic plans. Pakistan Vision 2025 is a programme for transforming Pakistan into a developed country through an inclusive process of engaging all the relevant stakeholders. Prof. Ahsan Iqbal, in his remarks, emphasized, "Our economic vision is built on self reliance and innovation. In past, growth resulted from foreign aid and loans but we want to mobilize domestic resources and promote exports. We seek to transform our low value product base to high value products by using technology, innovation and better management." He further said that the role of Governments in the contemporary world was only to provide a

platform to private enterprises, which are the major actors in the development of Pakistan's economy. The government's focus is on job creation by creating opportunities for greater investment in the country. Government has assigned high priority to fixing the energy crisis. Our development model places social development in the centre to build strong human resource base." Pakistan is an undermanaged country and PBC is the 'Management Capital' of Pakistan. We want partnership of private sector in the endeavors of developing Pakistan. Hardware of development is 50% of the story and software/social capital is the equal part of development equation. This software was missing in our development calculus, which we want to append.

International Trade & Finance Section

International Trade & Finance Section performed the following major activities during September, 2013:

- Updated information regarding External Sector of the economy. According to data released by Pakistan Bureau of Statistics (PBS), exports increased by 4.75% and stood at US\$1,996 million during August, 2013, imports decreased by 3.07% and stood at US\$3,572 million. The average exchange rate in the month of August, 2013 remained at Rs.102.93/US\$ against Rs.94.46/US\$ in August, 2012, showing a depreciation of 8.23 % for the same period last year.

- Prepared comments on Independent UNIDO Country Evaluation in Pakistan.

National Fertilizer Development Centre

Following are the recent major activities carried out with respect to fertilizer sector of Pakistan.

- Urea offtake during August, 2013 was 515 thousand tonnes, which increased by 59.9 % over August, 2012 (322 thousand tonnes). DAP offtake was 84 thousand tonnes, which registered an increase of 57.6 % as compared to August, 2012 (53 thousand tonnes).
- Total fertilizer nutrient offtake during August, 2013 was about 318 thousand tonnes compared to 206 thousand tonnes of August, 2012, showing an increase of 54.1 %. All major nutrients like nitrogen, phosphate and potash offtake increased by 54.9, 48.2 and 177.0 % respectively over August, 2012.
- NFDC arranged a meeting of all the stakeholders involved in urea

imports under the Chairmanship of Secretary, M/o Planning, Development & Reform to review the problems / issues / hurdles being faced in import of fertilizer and its distribution to the end users; and suggest a way forward in light of ECC Decision in respect of Case No. ECC-123/15/2013 (d) dated: 15th August, 2013.

Poverty Alleviation & MDGs Section

- Third meeting of Technical Group on Poverty was held on 6th September, 2013 in the Committee Room, 2nd Floor, M/o Planning, Development & Reform. Prof. Ahsan Iqbal, Minister for Planning, Development & Reform, chaired the meeting. The Minister made it clear that controversy over poverty estimation methodology needs to be discussed amongst the experts. It is necessary to resolve these issues for the sake of policy making. We do not believe in number-driven growth, which benefits only a certain class of people, rather a growth that is a broad-based and which drastically reduces poverty. Focus of our policies would be on vertical as well as horizontal poverty reduction. In today's case, the poor, who do not have access to knowledge and information, are at disadvantage. He emphasized to bridge the digital divide in order to realize the dream of pov-

erty alleviation. Mr. Shahid Naeem, Deputy Chief, Poverty Alleviation & MDGs Section made a detailed presentation on Poverty Estimation-Methodology and Measurement. Meeting was attended by the eminent economists/poverty experts. It was decided to organize a workshop on poverty estimation methodologies in near future.

- Ministry of Planning, Development & Reform prepared a draft of Pakistan Millennium Development Goals Report with the technical assistance of UNDP. A meeting to peer review the draft Report was held on 19th September, 2013 in Planning Commission. Ms. Marriyum Aurangzeb, MNA/Convener of Parliamentary Task Group on MDGs, chaired the meeting. The report will document Pakistan's experience in terms of successes and challenges in the journey towards

MDGs, narrate Pakistan's priorities for the post-2015 development agenda and will motivate a final push for the MDGs in Pakistan. Meeting was attended by representatives of the Federal and Provincial Ministries/Departments, and representatives from civil society organizations, academia and development agencies.

Public Investment Authorization (PIA) Section

During the reporting period, one meeting each of CDWP and ECNEC were held to strengthen the development activities and to minimize the development schemes backlog. The priority area remained energy and infrastructure sector projects. Details are as below:

- A CDWP meeting was held on 6th September, 2013 under the Chairmanship of Minister for P&D / Deputy Chairman, Planning Commission. The forum considered fifty four (54) projects and approved twenty-five (25) projects costing Rs. 15.154 billion. Four (4) schemes pertaining to Water Resources Sector, costing Rs.1638.366 million were approved and four (4) schemes with an estimated cost of Rs. 41.129 billion were recommended to the ECNEC for approval being within the competency of the ECNEC. In the Transport & Communication (T&C) Sector, four (4) schemes were approved at a total cost of Rs. 3421.872 million whereas same number of schemes were recommended to the ECNEC with estimated cost of Rs. 32.854 billion for approval. The CDWP deferred 10 schemes for further scrutiny whereas eight (8) schemes were withdrawn from the agenda due to various reasons.
- The Executive Committee of the National Economic Council (ECNEC) meeting was held on 13th September, 2013 under the Chairmanship of Finance Minister. The forum considered fourteen (14) projects out of which ten (10) projects with an estimated cost of Rs. 55.355 billion were approved and two (2) were deferred whereas two (2) projects were withdrawn from the agenda. The approved schemes included seven (7) projects of Transport & Communication Sector, two from Water Resources and one from Devaluation & Area Development Sectors.

Development and On-Farm Water Management for High Value and High Efficiency Agriculture Project (GZD-CADP) with estimated cost: Rs. 4300.796 Million, were drafted and submitted accordingly.

Brief/talking points for the inaugural session of the international poultry expo, 2013 were drafted and submitted to higher quarters accordingly.

Letters for meeting of the Main Committee for Clearance of Liabilities of "White Revolution – Doodh Darya Project / Pakistan Dairy Development Company were issued.

Nominations of officers of Agriculture and Food Section were conveyed to Training Section.

The requisite information received from Ministry of Ports & Shipping and Interior Division (ICT) Islamabad regarding Final Review of PSDP 2012-13 was forwarded to Public Investment Programming (PIP) Section.

Nutrition Section

The launching Ceremony of National Nutrition Survey (NNS) 2011 was held on 17th September 2013 in P-Block, secretariat, Islamabad, chaired by the Minister for Planning, Development & Reform and co-chaired by state minister, M/o National Health Services, Regulation & Coordination (NHS, R&C). The NNS 2011 indicated little change over the last decade in terms of core maternal and childhood nutrition indicators. With regard to micronutrient deficiencies, iodine status had improved nationally, while vitamin A status had deteriorated and there had been little or no improvement in other indicators.

Minister for Planning, Development & Reform, Prof. Ahsan Iqbal, emphasized the

need to announce a nutrition emergency across Pakistan in view of the deterioration of nutritional services in the last 10 years. The absence of these services has had an adverse impact on the physical and mental growth of our children, he remarked, while reaffirming the government's commitment to assume a stewardship role in streamlining nutrition interventions at the provincial level. Announcing the formation of the National Task Force on Nutrition, Mr. Ahsan Iqbal said, the ministries; PD&R, PC, NHSRC, National Food Security and Research (NFS&R), will also be closely involved in rolling out nutrition interventions, with the provinces being fully on board to achieve result-oriented out-

comes. He invited the media to offer inputs towards the development of a comprehensive communication plan, which will soon be deployed in local languages at the grassroots level.

A meeting of Universal Salt Iodization (USI) partners/ technical committee on USI was held at Micronutrient Initiative (MI) office in Islamabad on September 19, 2013 in which Chief, Nutrition Section participated to review, discuss and endorse the TORs for "Potassium Iodate Stability Study" in edible salt. Estimated cost of minimum food Basket report for the month of September, 2013 was compiled, which highlights national, provincial and regional estimates and comparisons, which are:

Education Section

- Cost for September 2013 compared with the previous month i.e. August 2013, remained almost same at national level, however increased 1% in Punjab and Baluchistan, while decreased by 1% in Federal Area, Sindh and Khyber Pakhtunkhwa.
- Cost comparison for September 2013 compared with the same month of last year September 2012, has increased by 8% at national level and Khyber Pakhtunkhwa, 9% in Federal Area and Sindh, 7% in Punjab and Baluchistan.

Pakistan Planning & Management Institute (PPMI)

During the month of September 2013, two (02) training courses were conducted by PPMI. Officers from Federal/Provincial Governments and Public Sector Organizations participated in these training courses. The brief of the training courses is as under:-

Public Procurement System (4-6 September, 2013):

This training course was designed to give awareness of Public Procurement System and to familiarize the participants with the efficient, transparent system of procurement and procedures to ensure that procurement in public sector is made competitively and contracts are awarded and managed in

a manner that promotes the paramount objective of value for money in government expenditure. Sixty Nine (69) officers participated in this training course. Mr. Muhammad Anwar Hussain Ch, D.G, PPMI awarded the certificates to the participants.

MS Project and SPSS (23-26 September, 2013):

This training course was designed to give awareness to the participants of the concepts of project planning using Microsoft Project. How to identify, organize and manage the tasks and resources required to complete a project under the constraints of time and cost to achieve a final project target

by using different techniques of Work Breakdown Structure (WBS), Gantt Chart, CPM,/PERT. As well as to improve understanding of the participants to work with SPSS, use of new features of SPSS and how to enter and reorganize information within SPSS and to enable them to use SPSS (Software) to produce scientifically sound research reports. Forty Five (45) officers participated in this training course. Mr. Muhammad Khurshid, Joint Secretary (Admin), Ministry of Planning, Development & Reform awarded the certificates to the participants.
