Terms & Conditions

- i. Interested bidders/ persons/ firms registered with Sales Tax Department as (active tax payers) can participate in auction of unserviceable scrap worth items of computer hardware, accessories and broken furniture & fixture etc. on the basis of “**as and where it is**”.
- ii. Interested bidders/ persons/ firms shall deposit Rs.100,000/- as earnest money deposit in shape of Pay Order in favour of Drawing & Disbursing Officer, Jawaid Azfar Computer Centre alongwith their bid. Bids without earnest money will be rejected (*Cheques are not acceptable*).
- iii. Sealed bid will be submitted for all items as “One Lot”, conditional and partial bids are not allowed.
- iv. Bidders shall submit valid copy CNIC, office address and telephone number/ cell no/ email/fax no, alongwith the bid.
- v. Items to be auctioned can be checked/ inspected on working days during office hours from 17th May, 2021 to 24th May, 2021 at Jawaid Azfar Computer Centre “P” Block Pak Secretariat, Islamabad. The undersigned may be contacted for further information in this regard.
- vi. The bid will be accepted on approval of the competent authority.
- vii. The successful bidder shall deposit 100% payment in Cash within three days on acceptance of the bid by the competent authority, failing which the bid will be cancelled and deposited amount forfeited.
- viii. The successful bidder shall pay all applicable Govt. Taxes as per prevailing rates in addition to the bid amount.
- ix. The auctioned material will be released/ handed over to the highest bidder subject to making 100% payment inclusive of all Govt. Taxes. The successful bidder shall remove the equipment within three working days.
