2. The eligibility criteria and objectives of the course are as under:

Eligibility Criteria


- Participants should have some basic knowledge in chemistry and biological sciences.
- Be Government employee and nominated by relevant Federal Ministry / Provincial Departments
- Proficient in spoken and written English.
- In good health

Objectives

- The course provides participants with a background of the major groups of toxic substances encountered by man and animals through food and the environment, and also through exposure at the workplace. These toxicants include mycotoxins, naturally occurring plant and animal toxins, toxic substances in air, water and soil, N-nitroso compounds, solvents, plastics, pesticides, pollutants and radiation (UN electromagnetic, ionizing). The course focuses on the chemistry, fate and distribution in the environment, mechanisms of their action, toxic manifestation in living organisms, as well as toxic syndrome in human beings.

Nomination of suitable candidates fulfilling the laid-down eligibility criteria prescribed by the sponsoring agency duly approved by the competent authority along with the following documents may kindly be forwarded to this Division by the close of business hours (4 Pm) 1st January, 2018 (Friday) positively.
