Program Objectives:

The aim of this programme is to promote capacity building of the participants working in Transportation Infrastructure, Energy Sector of the country which would be conducive to the development of the SAARC member countries.

Eligibility criteria:-

The applicant should:

- Be an officer in Federal or Provincial Government and working on transportation infrastructure ,energy
- Be a university graduates
- Be under 40 years of age
- Have an experience of studying or staying in Japan for more than three month are not allowed to take part
- Have visited Japan through any invitation program organized by Japanese Government, Ministries or agencies of Japan are not allowed to take part
- Have a command of spoken and written English
- Be in good health condition: if a participant's body temperature is 38.0°C on the day of departure, he/she cannot depart and not eligible to join in the invitation program in Japan.
