- Applicants must have never been expelled from any education institutions for misbehavior.
- Applicants must be healthy and have no conditions as an obstacle to study.
- Proficiency in English language
- Acquiring knowledge and ability in social development management and being able to be a coordinator between policy maker and policy implementer for social development
- Being able to employ knowledge from research to solve area based problems by designing and planning strategically for social development management in Thai social and cultural contexts through theories, research and dissertation
- Being able to drive social development in both locally and nationally by emphasizing on participation, preservation, reconstruction and efficiency consumption of natural resources and environment according to sustainable development concept.
- Being able to study in higher level both in Thailand and overseas.





9. Two official recommendation letters written in the letter head of referee's university.
10. One-page statement of Purpose, which includes field and level of study that you would like to apply for.
11. One-page CV affixed with a recent photo
12. A less than 6 month medical examination result.


